

FIELD TRIPS TO THE ELKINS/RANDOLPH COUNTY YMCA

Plan your school's next field trip to our YMCA; a place that specializes in FUN!

Field trips can be scheduled for up to four hours at the facility and tailored to meet your group's interests. Available activities include:

- GYMNASTICS ROOM: Gymnastics room activities can include an obstacle course, mini golf, parachute games or playing with our Imagination Playground.
- GYM: If sports are your thing, then pick a sport or allow your students to enjoy open gym time.
- RACQUETBALL ROOM: The racquetball room is a fun space to play Wally ball or beach ball volleyball.
- SWIMMING: Our pool can accommodate up to 40 swimmers at a time. The \$3/child fee includes one hour of swimming per child and includes staffed lifeguard. Additional chaperones for the pool area must be provided by the school.
- ROTARY ROOM: The Rotary room can be used for lunches or as a space to play games or activities.

COST:

- \$3 per child. Fees must be paid in advance of the trip unless paid by invoice from a local board of education.
- A \$50 clean-up fee will be assessed to groups larger than 100 students.

SUPERVISION:

All groups will be required to designate an individual, 21 years of age or older, who is responsible for the conduct of the group. The YMCA requires a minimum ratio of adult supervisors as follows:

- 1 adult to 8 children, 4 years to 5 years of age.
- 1 adult to 15 children, 6 years to 12 years of age.
- 1 adult to 20 children, 13 years to 25 years of age.



STANDARDS OF CONDUCT:

Any conduct contrary to the purpose of the YMCA is prohibited. Smoking is specifically prohibited in all areas of the facility. Consumption of alcoholic beverages and/or illegal drugs is specifically prohibited anywhere on the property or in the facilities. The YMCA reserves the right to dismiss any individual and/or group that does not maintain the rules of conduct.

CERTIFICATE OF INSURANCE:

All groups will be required to provide a Certificate of Insurance naming the YMCA as an "additional insured." Coverage extended to the YMCA shall not be less than the association carries and shall be provided prior to the event.

RESPONSIBILITY FOR DAMAGE:

The individual responsible for the group and the group as a whole shall be responsible for all damages to the facilities, property and/or equipment caused by the group. The group will be notified within 48 hours of the damage and payment required.

LOSS OF PERSONAL PROPERTY:

The YMCA assumes no responsibility for the personal property of individuals or groups utilizing the facilities and/or property.

USE OF YMCA NAME:

Use of the YMCA's facilities does not imply endorsement or sponsorship of any event by the YMCA. Therefore, promotion shall be designed in such a way that no suggestion of endorsement or sponsorship is implied.
